Hi Mike Walder's Low Some points from site visit this morning:

- The key view to this mound is from Bolsterstone (o/s Castle Farm) and this will not be affected (photo attached). This view is of high significance.
- The views from the cairn are to countryside to west, south and east over to Bolsterstone. The view to the NE is over the proposed housing site which has already been compromised by housing. Photo attached. This would be low significance.
- The mound is not visible from Cockshut Lane until you get to Bolsterstone.

The burial mound is the main asset and it's significance will not be affected by this development. The setting and related views are preserved and the significance can be appreciated. It will not affect the historic fabric. Therefore there is no harmful impact on the non-designated asset.

Michael,

Please find attached a Word version of the draft committee report with our latest amendments following our last discussion and receipt of additional inputs from your colleagues, kindly forwarded by you. We have not copied anyone else in so that you can determine who to involve in further discussions internally.

The attached version of the report has amendments as track changes for ease of review and retains some comments in the right hand margin where information is still required or, more pertinently, where clarification is required from the specialist officers consulted. Those comments 'faded out' have been addressed.

I think this needs to be finalised by you now as the issues set out are for officers to reconcile and for missing information requested by you, us and Katy to be supplied/inputted.

The main issues are:

Highways

• SCC Highways has provided a new consultation response drawing different conclusions on the site's accessibility by foot and public transport and access to services and facilities. This has implications which run throughout the whole report, particularly if this then leads to the conclusion that the site is not an accessible or sustainable location and therefore is not sustainable development. SCC needs

to review this and needs to confirm its final position. Notes are added throughout the 2nd draft document highlighting the areas of the report that this impacts.

- Some of the highways information that Katy requested hasn't been provided.
- We asked for the highway assessment section to be updated throughout but this hasn't been done and it now contains contradictions within the section itself and also with the updated consultation response section. We can't update this section ourselves as we don't know which bits the highway officer agrees / disagrees with and which bits are superseded.

Ecology

- Based on the updated information received, there still appears to be an outstanding ecology concern regarding impacts on Fox Glen LWS and the green link. This has implications for the policy LR5 assessment and needs to be resolved. Comments have been added into the report highlighting these
- There are also some outstanding ecology items in the consultation response section this may be because we haven't received all information. Again, markers have been added.

Non Designated Heritage Assets

SYAS has confirmed that the site falls within the setting of a non designated heritage asset (below ground). We need a firm conclusion on the level of harm, if any, that will be caused to this (nil or negligible) in order to apply the correct legal tests and assess it against NPPF para 197 if relevant. This is a key area for challenge if not properly addressed.

Notwithstanding the above, the report is nearly there but there needs to be consistency within it in terms of the above key considerations of harm.
